Spouse/Child of a Veteran of the U.S. Armed Forces

Bill® benefits (38 U.S.C. §3319) and the transferor is a member of the uniformed services who is serving on active duty; 3) Is using benefits under the Marine Gunnery Sergeant John David Fry Scholarship (38 U.S.C. §3311(b)(9))5; 4) Is using

benefits through the Survivors' and Dependents' Educational Assistance Program (DEA), (38 U.S.C. chapter 35) or 5) Is entitled to rehabilitation under 38 U.S.C. §3102(a).

Maryland National Guard

I understand that I must provide documentation from my company Commander for consideration.**

UMBC retains the authority to request additional documentation to supplement the items listed above. In extenuating circumstances, students may work with UMBC residency evaluators to determine alternative supporting documentation as necessary.
